This Memorandum of Understanding (here in after called MOU) was made between. M.G. CONTRACTORS PRIVATE LIMITED (Here in after called M.G. CONTRACTORS PRIVATE LIMITED) and Cosmo Analytical Lab I/p (Here in after called (CAL) Noida) for conducting Industrial Radiographic Testing, Ultrasonic Testing, Phased Array Ultrasonic Testing, Dye Penetrate Testing, Magnetic Particle Testing, Stress Reliving, Mechanical Testing and Chemical Testing for the raw material, equipment manufactured/fabricated by M.G. CONTRACTORS PRIVATE LIMITED at its works and various project sites.
The MOU made and entered on the 10 day of May 2026 between M.G. CONTRACTORS PRIVATE LIMITED & Cosmo Analytical Lab I/p (CAL)

Whereas M.G. CONTRACTORS PRIVATE LIMITED requires different tests for Weld Joints and raw materials including Mechanical & Chemical testing, Ultrasonic Testing, Phased Array Ultrasonic Testing and Radiography Testing, Dye Penetrate Testing, Magnetic Particle Testing, Stress Reliving tubes, pipe line and components. Now M.G. CONTRACTORS PRIVATE LIMITED and CAL come to an understanding that CAL (approved by BARC for RT, NDT level II approved person for UT, PAUT, MPT, DPT & NABL accreditation for Mechanical & Chemical Testing of Steel) will require NDT/ Destructive tests as and when required at M.G. CONTRACTORS PRIVATE LIMITED, works and other Project sites.

Further it was agreed that:-

CAL will provide required testing equipment along with qualified / approved manpower to conduct the tests. The equipment must the client's specification and may differ from client to client.

CAL will be responsible for safe transportation and storage of equipment as per AERB guide line. M.G. CONTRACTORS PRIVATE LIMITED shall provide required storage facilities and security arrangements atworks and other project sites

It is the responsibility of CAL show provides certificates on demand by client and requirement

may differ from client to client.

M.G. CONTRACTORS PRIVATE LIMITED has to send the samples (as prescribed standards) to CAL's Noida Lab for destructive & chemical analysis tests.

The prices shall be mutually agreed from time to time depending on quantum of tests, client requirements & location of tests.

M.G. CONTRACTORS PRIVATE LIMITED will provide one month's schedule by 25th of preceding month,
100% Payment shall be released at the time of submission of samples.

Testing and reporting shall be done as per CAL's approved format and procedures based on requirements of the customer.

Termination of the MOU shall be mutually agreed and not bounded to each other,

The MOU is valid for months from the date of signature i.e.: to 11th jULY 2032.
